Eligibility Requirements

- A maximum of THREE newly launched products may be submitted per company.
- Product must have been announced between May 1st, 2005 and April 30th, 2006.
- The products must in some way relate to Search and Rescue.
- Each product must be represented by an 18" x 24" poster presentation for display in the exhibition hall during the conference (please see below).
- At the conference, a business card size form will be attached to the front lower left hand corner of each poster presentation. This form will display the following:
 - Product name.
 - Product launch date.
 - Company name.
- Because presentation space must be accounted for beforehand, completed entry forms must be received no later than midnight on April 30th, 2006 (poster presentations must be delivered to the conference on May 19th).
- Each product's poster presentation delivered to the conference must match a previously received official entry form.
- Entries do not need to be represented to win, but you are responsible for delivering the poster presentation to the Best of What's New booth, at the conference. Please contact us for shipping details at bestof@wasar2006.org.
